Proposal 1

Rules changes to description of Flag Officers plus adding a new one for Vice Commodore

3.4 The Commodore is the principal Flag Officer and leads the club, ensuring the overall efficient functioning of the club in accordance with the wishes of the general membership. The Commodore normally represents the club at outside events.

Plus a new rule

NEW 3.5 The Vice Commodore is a Flag Officer and undertakes specific tasks/responsibilities as agreed with Committee. The Vice Commodore takes on the responsibilities of the Commodore if the Commodore is absent.

Other rules remain and are re numbered e.g.

NOW 3.6 The Rear Commodore is a Flag Officer and prepares and supervises the whole of the sailing programme, including the appointment and supervision of officers and personnel to manage each race. A Sailing Committee assists the Rear Commodore in these duties

Proposal 2

To revise rule 2.14 to encompass all activities of the club and a fair distribution of duties

Currently Reads

2.14 Members are required to assist in the preparation for, and the organisation of the sailing activities of the club. These duties will be shared with reasonable equity by all the Members and may, for example, include the activities of general maintenance, race management and provision of safety boat cover. Members must attend their duties or find a named substitute and inform the Rear Commodore (Sailing) accordingly. This ensures the safety of other Members during club sailing activities.
